


PREFACE

The Methodist Book Concern is now publishing the most complete Church membership records on the market. These new books have been prepared by the Committee on Church Records authorized by the General Conference of 1924.

The big, bulky, unwieldy Church record is a thing of the past. In its place are two small, neat volumes.

The reason for two instead of one is simple. All matters of unchanging data, as births, marriages, deaths, pastoral and statistical record, are in Book No. 1—HISTORICAL RECORD OF PERMANENT DATA.

This one volume might easily last a Church a hundred years. If verification of a birth or marriage a generation or two back were asked, one would open the book at his elbow, instead of having to go to safe or attic as in the old days, and turn over the musty pages of many a book, before the desired record were reached.

The membership itself is to be found in a separate volume—The Permanent Membership Roll. This is furnished in two bound volumes. Book No. 2 is in the modern form of an entire page for each family. Book No. 3 follows more nearly the customary alignment, allowing several families to a page. Where membership is constantly changing such a Roll has to be rewritten in a new book every few years. To avoid this making of books of which "there is no end," the Book Concern has issued the Permanent Membership Roll in Loose-Leaf form. With the Loose-Leaf, "removals" can be slipped out, and reinstated, for preservation in the back. If in time the book becomes too bulky, a separate binder can be secured for the "removals." Here again, in case of verification, the complete membership of a generation may be in a single volume—making the identification of a person's membership a simple matter.

The main objection that has been raised to a Loose-Leaf Book for recording Church membership is that its pages may be easily lost, and important records thus perish. The General Conference Committee on Records thinks this objection largely imaginative, and believes that the pastor will realize the necessity for the preservation of these leaves, and keep them in place "that none be lost."—FRED WINSLOW ADAMS, for the Committee.
